Chambers USA recognized Faegre Drinker in its 2022 edition, highlighting the firm in 72 practice area categories and 170 attorney designations on its list of America's leading attorneys for business.

Of the 72 total practice ratings for excellence, including 14 nationwide sections, the firm earned "Band 1" designations — the publication's highest ranking — in 19 categories across practice areas in Colorado, Illinois, Indiana, Iowa, Minnesota, New Jersey, New York and Pennsylvania, and nationwide.

A total of 170 Faegre Drinker attorneys were recognized by Chambers USA in 2022, with eight receiving multiple rankings. Of those ranked, 28 attorneys received "Band 1" designations.

Faegre Drinker ranked number 18 in the U.S. for brand strength by Thomson Reuters's Regional Law Firm Brand Indexes 2022.

The indexes are based on data compiled from Sharplegal in 2021 and include feedback from 692 senior legal buyers in the United States and 160 non-U.S.-based senior legal buyers. Brand strength is measured based on key factors legal decision-makers use when selecting firms, including top-of-mind awareness, favorability, consideration for top-level litigation and major M&A, and most used for high-value work.



CLIENT SPOTLIGHT: CUSTOMS & INTERNATIONAL TRADE

Lobbying Efforts Decrease Honey Tariffs from 400% to 58.74%-61.27%

A consortium of downstream U.S. honey purchasers, including several large food companies, faced supply chain concerns when presented with tariffs as high as 400% on imported honey. The color and flavor of the honey isn't available domestically and honey with these qualities mostly comes from Vietnam. Faegre Drinker represented the consortium with additional assistance from Faegre Drinker Consulting, presenting a coordinated lobbying effort. Following meetings with the U.S. Department of Commerce, as well as interactions with members of Congress, the tariffs were decreased from 400% to amounts ranging from 58.74%-61.27%, saving our clients between \$50 million and \$70 million.





Beyond buzz words

In partnership with Stanford Law School's Legal Design Lab, Faegre Drinker was one of the first law firms in the country to open its own in-house design lab in our Silicon Valley office in 2017. By **embracing innovation** through **design thinking and visual advocacy**, we help our lawyers communicate more effectively to solve our clients' most complex legal issues.

DESIGN LAB IN ACTION:

Faegre Drinker Secures Complete Defense Verdict for Seagate in a Major Patent Infringement Jury Trial

In April 2022, a Faegre Drinker intellectual property litigation team won a complete defense verdict for client Seagate Technology in a \$2 billion patent infringement jury trial in the Western District of Pennsylvania.

Following a two-week trial, the jury returned a verdict in less than one day finding that Seagate had not infringed any of the 10 claims brought by a former professor at Carnegie Mellon University.

In the case Lambeth Magnetic Structures v. Seagate Technology Holdings et al., Lambeth had filed suit against Seagate claiming that several microscopic layers in the write heads of Seagate's hard drives infringed a patent he obtained in 2006. On behalf of Seagate, the Faegre Drinker team argued that the hard drive write heads did not follow the structure of ultra-thin magnetic layers and crystals described in Lambeth's patent. The also team partnered with Faegre Drinker's Design Lab to create visual advocacy models to teach the jury the underlying complex technology in the patent.

2022 SPOTLIGHT:

Reversal on Appeal of Multimillion-Dollar Jury Verdict in California

On May 26, 2022, the California Second District Court of Appeal reversed a jury verdict on damages against Zimmer, Inc. and granted a new trial on that issue. On behalf of Zimmer, Faegre Drinker argued that the trial court erred by excluding all of Zimmer's proffered expert medical opinions on possible alternative causes of claimed injury that were not expressed to a reasonable medical probability.

In Kline v. Zimmer, Inc II., a damages-only retrial, the jury awarded the plaintiff over \$7.68 million in economic and non-economic damages for personal injuries. On appeal, Faegre Drinker argued that the trial court had erroneously barred Zimmer from presenting any expert testimony about possible alternative causes for the plaintiff's injuries, a primary issue in the case. The Court of Appeal agreed with Zimmer, stating that the trial court had applied the wrong evidentiary standard and that the trial court's categorical exclusion of Zimmer's expert testimony on this central issue deprived Zimmer of a fair trial. The exclusion of this expert testimony, the Court of Appeal concluded, was a structural error in the trial and entitled Zimmer to a new trial.

Pentair Acquires Manitowoc Ice for \$1.6 Billion

Faegre Drinker advised Pentair plc in its acquisition of Manitowoc Ice, a leading provider of commercial ice makers, from Welbilt, Inc. for \$1.6 billion. Pentair's President and CEO noted that the strategic acquisition allows Pentair to enhance and deliver its total water management offerings to an expanded network of channel partners and customers, further establishing Pentair as a leader in a vast and growing industry. Welbilt's sale of Manitowoc Ice to Pentair paved the way for Welbilt to complete its sale to Ali Group in a larger transaction that involved regulatory approvals from the U.S., United Kingdom and European Commission.

Amici Curiae Brief Addresses the Enforceability of Arbitration Provisions in ERISA Plan Documents

Faegre Drinker filed an amici curiae brief on behalf of the ESOP Association and American Benefits Council in Ramon Dejesus Cedeno v. Argent Trust Co. et. al. The brief was filed in an appeal of a district court ruling that could effectively ban individualized arbitration of ERISA fiduciary-breach claims. This case is one of several that address the enforceability of arbitration provisions in ERISA plan documents. In the appeal, the Second Circuit will address whether an ERISA plan can require individualized arbitration of ERISA fiduciary-breach claims.

The district court held that a participant in an ERISA plan has a right to pursue all loss to an ERISA plan, not just the individual's loss in a plan account, and that an agreement requiring individualized arbitration was unenforceable. The amici curiae brief provided an analysis of ERISA's legislative history and principles of the common law of trusts, arguing that this contextualized information demonstrates that ERISA permits individualized arbitration. The brief also argued that banning individualized arbitration would create an environment prone to prohibitively high risks of litigation, and the district court's ruling would undermine Congress' goal of striking a balance between a participant's rights to benefits and protecting plans against excessive litigation.



Wells Fargo Issues \$2 Billion Sustainability Bond

Faegre Drinker represented Wells Fargo in its issuance of a \$2 billion Inclusive Communities and Climate Bond, the financial services company's second Sustainability Bond, which will fund projects and programs that support housing affordability, economic opportunity, renewable energy and clean transportation. Faegre Drinker also represented Wells Fargo in the issuance of its inaugural Inclusive Communities and Climate Bond in May 2021.

Wells Fargo engaged BurgherGray LLP, a minority-owned law firm, as co-issuer's counsel on the offering. Wells Fargo Securities, LLC served as a bookrunner for the issuance, joined by five broker-dealers whose owners include people of color, women, and service-disabled veterans. They, along with 19 additional diverse broker-dealers whose owners are from underrepresented groups, received 75% of the underwriting fees from the offering.


